## Starting from September 1, 2024, V.N. Karazin Kharkiv National University welcomes foreign citizens and stateless individuals to study in Dual degree Programmes

**Dual degree Programmes** are joint educational programs of Ukrainian and foreign higher education institutions that allow students to obtain two university diplomas simultaneously by studying integrated educational programs at two educational institutions in different countries.

As a rule, students may work for dual degrees in the same area or in two different subjects. In addition to this, it takes less time to earn two degrees within dual degree programs than it would have taken to receive them separately.

The global job market of the day demands not only a diploma with excellent grades, even from the most prestigious Ukrainian university, but also requires job seekers to have a broad worldview, strong practical skills, and high-level proficiency in a foreign language. All of this and much more is provided to participants by the Dual degree Program.

Studying in Dual degree Programmes implies that the foreign student will simultaneously pursue higher education at two universities:

- Karazin University provides education according to the chosen specialization within the corresponding educational and professional (academic) program, while a partner institution provides education according to the specialization offered by the joint educational program;

- Credits earned by the student at Karazin University are recognized by the partner institution;

- The partner institution organizes the educational process in the form of full-time education (offline);

- The language of instruction at the universities is either Ukrainian or English.

### Advantages of Dual degree:

1. *Academic diversity.* Students have the opportunity to study different subjects and specializations at both universities, which enhances their knowledge and skills.

2. *Mastery of foreign languages*. Dual degree contribute to improving proficiency in foreign languages, which is utterly advantageous in the modern world.

3. *Professional networking*. While studying at two universities, students build a network of professional contacts abroad. This can be extremely beneficial for future careers.

4. *International experience*. A significant advantage of dual degree is the opportunity to gain international experience in studying and working in two different environments. This broadens the student's horizons and enables them to adapt to various conditions and requirements.

## Educational and professional program "Marketing"

### (first (Bachelor's) and second (Master's) levels of higher education)

The program is aimed at acquiring basic knowledge for making management decisions in various marketing areas; justification of recommendations for forming marketing policies; obtaining all necessary competencies in collecting and processing primary and secondary market information; using modern technologies and methods for conducting marketing research; developing skills in modelling and forecasting the business environment; ability to segment markets and position objects in the economic environment. Specializations: Information Marketing, Advertising and Public Relations, Marketing, Marketing Management.

## Educational and professional program "International Economics"

(first (Bachelor's) and second (Master's) levels of higher education)

International Economics is a complex of scientific disciplines, sections, and directions of economics, aimed at forming a system of primary professional knowledge in international economics, conditions, forms, methods, and the basic toolkit of international economic activity.

## Educational and professional program "Accounting and Taxation"

### (first (Bachelor's) and second (Master's) levels of higher education)

Management accounting allows summarizing information about organizational operations using special methods. The accounting information in a systematic form represents a kind of "chronicle" of the company, its "business archive", without which the organization cannot exist and develop, make managerial decisions, or be attractive to investors.

### Educational and professional program "Digital Finance and E-commerce"

### (first (Bachelor's) level of higher education)

The program, unique in Ukraine, is designed to prepare finance professionals who have a deep understanding of the principles and intricacies of IT business and electronic commerce.

### Educational and professional program "Administrative Management"

#### (second (Master's) level of higher education)

The program is aimed at preparing professionals capable of identifying and solving complex specialized tasks and practical problems in the field of organizational management based on the acquisition of a system of competencies. A distinctive feature of the program is the participation in simulation practice, which has an experimental nature, and pre-diploma practice in leading institutions and organizations.

### Educational and professional program "Public Finance"

#### (second (Master's) level of higher education)

The goal of the program is driven by the extensive implementation of modern methods of managing public finances and the public sector of the economy and government bodies, integration into the European space, and decentralization in the country. The combined focus of the program (academic and practical) involves orientation towards the application of modern methods of researching financial processes, analysing the interaction of economic phenomena to solve theoretical and practical tasks of the modern economic environment in the field of public administration and management.

### Educational and professional program "Applied Economics"

#### (second (Master's) level of higher education)

The program is designed to train professional analysts versed in various aspects of economic activity, expert in modern information technologies and modelling techniques as effective tools for decision support and decision outcome prediction. Studying under the program allows acquiring knowledge in theoretical and applied economic disciplines, mastering the technologies of mathematical and computer modelling and information technologies, ensuring the ability to professionally apply acquired general scientific and specialized knowledge in practice.
