## REQUIREMENTS FOR THE ABSTRACTS LAYOUT

### General technical requirements for the layout of abstracts:

- ✓ text editor Microsoft Word; sheet format - A4; font - Times New Roman; font size - 14 point; spacing - 1; paragraph indentation - 1.25; no tabs / hyphens;
- ✓ page parameters: sheet format - A4, all 2 cm borders;
- ✓ the volume of abstracts is 3-5 pages;
- ✓ distinguish between a dash (–) and a hyphen (-) in the text;
- ✓ use quotation marks only of the following sample: “ ”;
- ✓ put one space between words.

### Structure of abstracts:

*Abstract title* – capital letters, bold, centre alignment, up to ten words.

*First name* (lowercase) and *last name* (uppercase) of the author(s) – bold, centre alignment.

*Information about the author(s)* – academic title, academic degree, position; full official name of the institution(s), city, country – normal font, centre alignment.

*The main text* starts through a line, with a paragraph.

The text should be structured (contain *a general statement of the problem* → *presentation of the main material* → *conclusions*), but these elements do not need to be separately highlighted.

The *references list* is compiled in alphabetical order (in the original language) in accordance with the requirements of the National Standard of Ukraine DSTU 8302: 2015 “Information and Documentation. Bibliographic references. General provisions and rules for compiling”. The DOI digital identifier (if available) should be added to the source.

Bibliographic references are given in square brackets ([43, p. 43], [17, pp. 39–43]) where the first digit is the number of the source in the list of references, the second is the page number.

*Appendix 2*

**GENERAL REQUIREMENTS FOR POSTER PRESENTATIONS**

1. The poster presentation consists of a poster and an oral comment (scientific report) by a postgraduate student.
2. The poster is executed in A4 format.
3. The poster should include the title of the thesis, information about the postgraduate student and the supervisor, the main results of the study.
4. Textual information is accompanied by appropriate illustrative material (diagrams, charts, tables, figures, photographs).
5. Up to 5 minutes are allocated for an oral presentation.
6. Criteria for evaluating the poster presentation: content and clarity of the presentation of research results; thoroughness of research problem's essence disclosure; reasoned presentation and practical significance of the research results; oratory skills in presenting research materials.
