INTRODUCTION

The program of the discipline "Foreign Language for Professional Purposes" / "Foreign Language" (Second Language) is drawn up in accordance with the educational and professional training program for the second (master's) level of higher education; field of knowledge 22 "Health care"; speciality 222 "Medicine"; educational qualification "Master of Medicine"; professional qualification "Doctor".

1. Description of the discipline

1.1. The purpose of teaching the discipline

The purpose of studying the discipline "Foreign Language for Professional Purposes" / "Foreign Language" (Second Language) is to develop professional and communicative competence in future specialists. Applicants for higher education at the School of Medicine of the English-language form of study must master the language at the level of program requirements (at the level of professional communicative sufficiency). This involves improving the skills and abilities acquired at the previous stage of study in all types of speech activities – reading, writing, speaking and listening, as well as in the use of language tools to implement tactics of speech behaviour for successful communication. The basis for the formation of communicative competence is mastering the Ukrainian language systems: phonology, lexis and grammar.

Program competences. For international students, Ukrainian-language communicative competence is the basis for the formation of general and professional competences provided by the educational and professional program.

General competences: 1) GC 1. Ability to think abstractly, analyse and synthesise; 2) GC 2. Ability to learn and master modern knowledge; 3) GC 3. Ability to apply knowledge in practical situations; 4) GC 4. Knowledge and understanding of the subject area and understanding of professional activity; 5) GC 5. Ability to adapt and act in a new situation; 6) GC 6. Ability to make informed decisions; 7) GC 7. Ability to work in a team; 8) GC 8. Ability to interpersonal interaction; 9) GC 9. Ability to communicate in a foreign language; 10) GC 10. Ability to use information and communication technologies; 11) GC 11. Ability to search, process and analyse information from various sources; 12) GC 12. Determination and perseverance in relation to the tasks and responsibilities undertaken; 13) GC 13. Awareness of equal opportunities and gender issues.

Professional competences: 1) PC 1. Ability to collect medical information about the patient and analyse clinical data; 2) PC 16. Ability to maintain medical records, including electronic forms; 3) PC 25. Observance of professional and academic integrity, responsibility for the accuracy of scientific results.

1.2. The main tasks of studying the discipline

- Foreign students master perceptive and productive language skills in the field of educational and professional communication at the elementary level.

- Foreign students acquire language and gain professionally oriented knowledge to achieve the communicative goal and meet personal needs in a limited set of topics and situations of educational and professional communication.

- Promoting the fundamentalisation of general vocational education by deepening it through the study of a foreign language (Ukrainian) in a professional context.

1.3. The number of credits is 4.

Education in Ukrainian higher education institutions is organised on the basis of the credit-transfer cumulative system, and therefore the curriculum of the School of Medicine allocates 4 credits for the discipline "Foreign Language for Professional Purposes" / "Foreign Language" (Second Language).

1.6. Planned learning outcomes

As a result of studying the discipline of "Foreign Language for Professional Purposes" / "Foreign Language" (Second Language), higher education students must achieve the following program learning outcomes:

1) PLO 1. Have a thorough knowledge of the structure of professional activity. Be able to carry out professional activities that require updating and integrating knowledge. To be responsible for professional development, the ability to further professional learning with a high level of autonomy.

2) PLO 5. Collect complaints, anamnesis of life and disease, assess the patient's psychomotor and physical development, the state of organs and body systems, evaluate information on the diagnosis (according to list 4) based on the results of laboratory and instrumental studies, taking into account the patient's age.

3) PLO 21. Find the necessary information in professional literature and databases of other sources, analyse, evaluate and apply this information.

4) PLO 25. Clearly and unambiguously communicate own knowledge, conclusions and arguments on health care problems and related issues to specialists and non-specialists.

5) PLO 27: Communicate fluently in the state language and English, both orally and in writing, to discuss professional activities, research and projects.

The background for achieving above mentioned learning outcomes will be the following developed communication skills:

Reading: to read, understand and reproduce texts in the academic, professional and socio-cultural spheres;

Listening: listen to texts and speech of participants in a communicative situation on topical issues of the educational and professional sphere and the socio-cultural sphere;

Speaking: to produce an (unprepared) utterance; to engage in dialogue and policing.

Writing: to express thoughts in writing in accordance with the linguistic norms of modern Ukrainian literary language.

2. Thematic plan of the discipline

Section 1. Fundamentals of professional speech.

Topic 1. Respiratory system. Language means of professional speech in pulmonology and ENT departments.

Subject-predicate relations in a simple sentence. Ways of expressing the subject and predicate. Qualification of the subject (phenomenon). Characteristics of the subject (person). Use of professional terminology: study of active vocabulary, grammatical

forms, syntactic structures related to the respiratory system. Producing dialogues and monologues on educational, professional and socio-cultural issues. Reading texts in the academic and professional sphere of communication.

Topic 2. Cardiovascular system. Language means of professional speech in the cardiology department.

Object relations in a simple sentence. The designation of a direct object (apposition). A direct object expressed in the form of the accusative case without a preposition. Transitive and intransitive verbs. Perfective and imperfective verbs (repetition). Verb control. Use of professional terminology: studying active vocabulary, grammatical forms, syntactic structures related to the cardiovascular system. Producing dialogues and monologues on educational, professional and socio-cultural issues. Reading texts in the academic and professional sphere of communication.

Topic 3. Digestive system. Language means of professional speech in the gastroenterology department.

Object relations in a simple sentence (continued). Indication of an indirect object. Indirect object expressed by the form of the genitive case without a preposition; the dative case without a preposition. Indirect prepositional complement expressed by the form of the genitive case and the preposition \mathbf{sid} ; the dative case and the preposition \mathbf{sid} ; the dative case and the preposition \mathbf{sid} ; the instrumental case and prepositions $\mathbf{s/y}$, \mathbf{na} . Verbs of double control. Use of professional terminology: learning active vocabulary, grammatical forms, syntactic structures related to the digestive system. Producing dialogues and monologues on educational, professional and socio-cultural issues. Reading texts in the academic and professional sphere of communication.

7. Teaching methods

The following methods of teaching foreign students are aimed at achieving educational goals:

- *conscious-practical* (the leading method of teaching foreign languages, because, on the one hand, during practical classes, students become aware of the language forms necessary for communication; on the other hand, language material is mastered through foreign language and speech activities);

- *explanatory and illustrative* (used to teach and learn new educational material, facts, approaches, assessments, conclusions, etc.);

- *reproductive* (for students to apply the algorithm learnt on the basis of a model or rule, which corresponds to the instructions, rules, in situations similar to the model presented);

- *the method of problem-based teaching* (using various sources and means, in teaching foreign students, the teacher poses a problem, formulates cognitive tasks, and then, revealing the system of proofs, comparing views, different approaches, shows ways to solve the task; thus, students become accomplices in scientific research);

- *partially searching or heuristic method* (in the organisation of active search for solutions to cognitive tasks put forward by the teacher (or independently formulated under the guidance of the teacher, based on heuristic programs and instructions). The thinking process becomes productive, but it is gradually guided and controlled by the teacher/students in working with textbooks and computer programs. This method, one of the varieties of which is a heuristic conversation, is an effective way to activate thinking and encourage cognition);

- *research method* (after analysing the material, setting problems and tasks and brief oral or written instructions from the teacher, students independently study literature, sources, conduct observations and perform other search activities. Initiative, independence, and creative search are most fully manifested in research activities. Methods of educational work are directly transferred to methods that imitate and then implement scientific research).

8. Control methods

Routine control is carried out at each lesson. It is used to check the level of skills and abilities in all types of speech activities.

Final control: a test (in written and oral form) is held at the end of the 5th semester.

Requirements for test materials:

Lexical and grammatical tasks.

Written and oral modelling of a professional dialogue on the proposed topic.

The execution time is 80 minutes.

Evaluation criteria:

The total score is 80 points.

Lexical and grammatical tasks are worth a maximum of 40 points.

Oral dialogue (a simple dialogue of 10-12 sentences within the program list of speech situations in the educational and professional sphere) is assessed with a maximum of 40 points, of which:
